Note: indoor spaces are in the exhibit hall and under the grandstand area. Under the grandstand has both 8.5' x 14' and 9' x 10' spaces with some height limitation. For outdoor set up you must have your own set up (NO STAKES ON TENTS. THEY MUST BE WATER BARREL OR SANDBAG). We rent the space only...no table, chairs, water barrels, etc. The new midway buildings are either 12' x 12' or 12' x 24'. The exhibit hall is made up of 9' x 10' spaces. Indoor booth hours are 10:30 am to 9:30 pm, outdoor/midway hours 10:30 a.m. to 10:30 p.m. and must be staffed all hours, all days of the show. **Insurance is required by all exhibitors and must be purchased through CFD's Insurance company.**
