The Cheyenne Frontier Days General Committee is pleased that you are interested in applying for Miss Lady-In-Waiting. If you are selected, you will have one of the most enjoyable and exciting years of your life. You will also have the opportunity to be selected the following year as Miss Frontier.

#### **Requirements:**

- 1. Applicant must be a resident of Laramie County.
- 2. Applicant must be a high school graduate at time of application.
- 3. Horsemanship skills demonstration (Horse will be provided & riding pattern is provided). Horsemanship will take place on Sunday, August 25th at 4:00 PM at the CFD arena. In case of inclement weather, Barn 13 will be the alternate location.

Officially, you will be under the direction of the Indians Committee Chairman. You will be under the guidance of Miss Frontier, who will assist you in learning your role as a spokesperson for Cheyenne Frontier Days.

You will be asked to make many personal appearances, speaking at many, and to be interviewed for newspaper articles, radio, and television. Many of these will be overnight and you should be prepared to stay out-of-town for several days. Some will be without notice, but you will still be expected to handle yourself with poise and dignity, and always with a smile.

You will represent Cheyenne Frontier Days at rodeos as approved by the Cheyenne Frontier Days General Committee, such as the National Western Stock Show and the Greeley Independence Stampede. You will have speaking engagements with organizations throughout the reign. You will be interviewed by national and regional media. Your very best personal appearance is always a requirement as well as your ability to remain cool and calm in any situation.

Your purpose is to promote Cheyenne Frontier Days and the heritage of the Old West. To do this, you should prepare yourself by learning the history of the "Daddy of 'em All" ® and by learning a great deal about rodeos in general, and something about today's participants. You must be current on all activities of Cheyenne Frontier Days.

Applications are due to the Cheyenne Frontier Days Headquarters, 1230 W. 8<sup>th</sup> Avenue, Cheyenne, WY 82001, by 4:00 pm on Friday, August 23<sup>rd</sup>. Applications must be accompanied by a notebook/portfolio, which details your accomplishments and background. Any letters of recommendation should be included in your notebook or hand delivered to Headquarters prior to the personal interview date. Content, organization, accuracy, and clarity of materials in this application and notebook will be used as criteria to select the next Lady-In-Waiting.

All applicants are required to appear before the Cheyenne Frontier Days General Committee for Horsemanship judging on Sunday, August 25, 2024, at 4:00 pm and a Personal Interview on Monday, August 26, 2024 at 5:30 PM at CFD Headquarters.

All personal appearances and those which result in newspaper pictures or television, require the Frontier Days Royalty to be on time, on their best behavior, and in proper western apparel.

Alcoholic beverages will not be consumed by Royalty at any official function.

An official of the Cheyenne Frontier Days Committee or its designee will accompany Miss Frontier and her Lady-in-Waiting at all appearances.

I am a resident of Laramie County, and as of this date of application have graduated from high school.

I understand that my selection as Lady-In-Waiting for Cheyenne Frontier Days is a one-year obligation, and I agree to adhere to the guidelines set-forth by the Cheyenne Frontier Days Committee. ## Horsemanship Sunday, August 25, 2024 at 4:00 pm

Miss Frontier and the Royalty Coordinator will welcome you at Cheyenne Frontier Days (CFD) Event Center and a group photo will be taken with all applicants and Miss Frontier. When all applicants have arrived, you will draw numbers to determine the order of the horsemanship demonstration. The Indians Committee Chairman will call into Headquarters to request each applicant. When it is your turn, you will drive yourself in your own vehicle to the arena, where you will mount the horse provided by CFD. Once your demonstration is finished, you will then leave Frontier Park without speaking to the other applicants.

The Royalty Coordinator will ask for your telephone numbers and parents' names.

# Formal Interview Monday, August 26, 2024 5:30 pm ~ Brief welcome and group photo 5:45 pm ~ Interviews begin


Miss Frontier and the Royalty Coordinator will welcome you at the CFD Event Center for an ice breaker. When all applicants have arrived, you will draw numbers to determine order of the interviews. The Indians Committee Chairman will escort the applicants, one at a time, into the meeting room to be interviewed by the CFD General Committee.

After each applicant is interviewed, she will be asked to return home without speaking to other applicants.

Once a decision has been reached, telephone calls will be made to all applicants.

The successful applicant will be asked to return to CFD Headquarters with her family, including brothers and sisters, to take photos and to celebrate!

#### REINING PATTERN NUMBER 2



Horse must walk or stop prior to starting pattern.

Beginning at the center of the arena facing the left wall or fence.

- 1. Beginning on the right lead, complete three circles to the right: the first circle small and slow; the next two circles large and fast. Change leads at the center of the arena.
- 2. Complete three circles to the left: the first circle small and slow; the next two circles large and fast. Change leads at the center of the arena.
- 3. Continue around previous circle to the right. At the top of the circle, run down the middle to the far end of the arena past the end marker and do a right rollback no hesitation.
- 4. Run up the middle to the opposite end of the arena past the end marker and do a left rollback no hesitation.
- 5. Run past the center marker and do a sliding stop. Back up to the center of the arena or at least ten feet (3 meters). Hesitate.
  - 6. Complete four spins to the right.
- 7. Complete four spins to the left. Hesitate to demonstrate the completion of the pattern.

Rider may drop bridle to the designated judge.
